VETERINARY CONSULTATION 2009

Dear Client,

I am honored that you are willing to trust me with the care of your animal. As you are probably aware, my methods of prevention and treatment of illness and pain are not the usual ones. What I have to offer represents 48 years of veterinary practice; 16 years of orthodox medicine and the past 32 in holistic healing. It has been the past 32 years that have been my most rewarding because I have been able to do so much more for my patients with holistic energy medicine. All animals (and People) exist on two planes: the physical and the energetic. I have proven this to myself with Kirlian photography, and with a sophisticated electronic machine (called the Dermatron) made in Germany that utilizes EAV. I have photographed the Life Force flow around the toes and fingers of people and animals, and have measured this energy output of the physical organs via their acupuncture points on the Dermatron. This energy represents Life's force, Chi, Electromagnetic energy field or EMF- these are all terms of the same energy that is responsible for our physical health. Energy output on the machine records normal, abnormally high values (inflammation/infection) or abnormally low values (degeneration or cancer). A perfectly healthy animal physically and energetically shows a visual strong unbroken aura on Kirlian photographs, and normal energy outputs on all acupuncture organ points on the Dermatron. Ill or painful animals show breaks in the visual aura and a diminution of the width or depth of this energy. Energy values on the organs with the Dermatron show abnormally high or low values from the norm.

EAV stands for Electro acupuncture According to Voll. Dr. Reinhold Voll, in Germany, developed the technique of monitoring the health of a person by the energy emitted from his acupuncture points of each organ. Dr. Voll was able to put into the same circuitry, homeopathic remedies (Classical Hahnemann as well as those made from disease causative agents called nosodes.) Nosodes are homeopathic remedies made from disease producing bacteria, viruses, fungi, chemicals, drugs, vaccines, heavy metals, pesticides, food preservatives, etc. When these homeopathic remedies and nosodes changed the abnormal readings to normal, this told him what was causing the disease, and what had to be given the patient to get well. I studied with Dr. Voll in Germany, researched his EAV methods in animals for 2 years, published my results and taught other holistic veterinarians the methods. Over the past 22 years, I have seen a pattern of disease/pain in our animals and know what has to be done to make these sick animals well. **This is the basis of my treatment. It is a program that requires the full commitment of the pet owner to work with me to achieve success. Sometimes in early cases that success comes quickly, in older animals or where the process has been going on some time it may take several months to get that animal well. But it has been done.**

It requires a change in lifestyle of the way an animal is cared for to prevent future exposures to toxins: absolutely no commercial diet is allowed, only home made DETOXED foods, no drugs (except in life-threatening situations,) cortisone, heartworm preventative, insecticide drugs, nor drug vaccinations. EVER! Since these are the sources of the ill health. My program is one of **Sequential Nosodal Detoxification** of all past exposures to vaccinations, heavy metals and other chemical contaminants in the diet, and medical drugs: starting from the most recent exposures to cleanse from the animal's system, in serial sequence to the very earliest in life. Pet owner knowledge of the program is essential, and that is why I have written newsletters, some of which will be required reading in order for us to accomplish a successful goal of returning your pet to good health. **Support** to your animal, is given with natural products of homeopathy, herbs, glandulars, orthomolecular supplements and energy –charging devices such as my Healing Halter (that I have developed and has healed animals for 20 years), and the use of acupressure point massage charts that the owner can do at home to potentiate healing. I recommend quartz crystal charging of the animal's water, use of oral oxygen drops and Bovine Colostrum – Mother Nature's natural antibiotic, fungicide, viricide and immune system balancer. With my methods, if followed correctly, we hope to achieve our goal of making your animal's Life Force so strong, that

it will help to prevent any parasite (that includes cancer cells) from entering the EMF. This is TRUE PREVENTATIVE MEDICINE. I have seen it work in people (Dr.Voll's practice) and it has been successful in my own practice. Failures occur when there is irreversible damage to an animal's organ/immune system and when owners give up prematurely, before we achieve our goals.

It must be understood that I cannot examine your animal physically; however, I can draw on my many years of experience with cases like yours. I require a detailed owner questionnaire on your animal's name, birth date, breed, sex, if neutered or spayed, diet fed, any past traumas, scars and locations of scars, symptoms of illness, 4 photos of your animal,(front view, side view, back view and dorsal view with no other life form in the photo). I also need copies of ALL medical records going back to puppy vaccinations, if possible, to the present time. I need medical copies of all laboratory tests, X-rays, surgeries and drug and vaccination administration to your animal. For the past 2 years. I ALSO REQUIRE AN ATTENDING VETERINARIAN TO WORK COOPERATIVELY with me and you. A **Veterinary Consult Agreement** must be signed by the attending veterinarian. I will study these in detail, and then give you my professional opinion of what must be done to help your pet. I believe I offer something unique and time tested in my own practice of 32 years of holistic therapies.

Because I require total commitment to my program, it requires the working of a 3 man team, me you, and the local attending veterinarian. If this cannot be done, I would prefer you to receive care from another practitioner.

Because of the nature of my program and the amount of time I must dedicate to each case, it is difficult for me to handle more than a few cases. Due to the extensive time I must spend on each case, I do not want any misunderstanding of fees therefore I refer you to my fee schedule below. You should not expect me to be available on a 24- hour basis, although I do try to be available as much as possible. If there should be a life- threatening emergency occur, and I cannot be reached in a timely manner, you can use an emergency facility near you and we will deal with the situation after the animal is stable.

Fee Schedule: 2009 Professional Veterinary In Depth Consultation charge: \$ 415.00 for approx 8 hours or more of initial work up including report of findings. Owner must submit filled out questionnaire, last two years veterinary records, lab tests, and attending local veterinarian must sign Veterinarian Consultation Agreement. Dr. Dodd's services are \$415.00 + treatment. Dr. Dodd will do a few selected seriously ill cases a month. Please be aware that these involve only the most seriously ill animals and **expect custom made specifically formulated remedies and supplemental support products to be approximately \$400-\$1200.00 depending on how extensive the treatment and support must be. If there is any question of financial hardships, please contact Dr. Dodd immediately before the 8 hour reading is done.** "

It is faster to consult by telephone in complex cases after paperwork (completed animal history form, medical records and photos of animal, with Declaration of Acceptance and credit card information) is submitted by fax, or email. **Medications and other services/shipping and handling fees found relevant for treatment are charged separately. If owner desires an approximate estimate of the prescribed initial treatment, this should be stated at the beginning of the consultation and charges will not be processed until approved by email, fax, or phone. Emails,faxes, letters, and telephone calls made by Dr. Dodd, will be charged at \$25.00 @.**

After initial treatment, Follow up Consultation of animal's response and further treatment outline will be charged at \$255.00 for approximate estimate of 5 hours work + medications/supplements/ other services/ shipping and handling fees needed
